PERFORMANCE RESPONSIBILITIES:

- Implement the health curriculum frameworks and program standards set by the Indiana Department of Education.
- Demonstrate instructional abilities in planning curriculum, including goal-setting skills.
- Evaluate students in theory and clinical practice.
- Effective written and verbal communication, with appropriate interactive skills dealing with students, peers and the community.
- Maintain school records effectively.
- Utilize learning resources such as media to implement competency-based education.
- Evaluate and update curriculum as needed.
- Encourage students to continue their educational process and assume responsibility for self-development.
- Teaches students the occupational competencies necessary for employment.
- Prepares course competency based outlines for each instructional course or program.
- Prepares detailed lesson plans and laboratory experiments for all units of instruction.
- Supervises all student clinical experiences.
- Develops a schedule for each semester.
- Reviews and selects instructional materials such as text books and audio visual materials.
- Completes requires for supplies and other instructional materials on a timely basis.
- Completes enrollment and follow-up reports.
- Assists in the development of an annual budge for the instructional program.
- Maintains a clean and safe classroom and laboratory environment.
- Recommends new and/or replacement equipment to be purchased for the program.
- Maintains proper inventory of all equipment and tools assigned to the program.
- Keeps equipment functioning and in good working order by establishing an effective preventative maintenance system.
- Maintains an active advisory committee, which meets twice a year.
- Visits industry for the purpose of developing good rapport with potential employers.

- Takes an active role in the advisement and counseling of students.
- Helps students find employment in an occupation related to training.
- Fulfills the requirements of career license certification by attending specified classes and workshops.
- Attends faculty meetings and workshops.
- Performs other duties as assigned.
